In the event of any lawsuits or claims regarding ADA violations, Coldwater
 Excursions will take full responsibility for resolving the issue. If found in violation of
 the ADA, we will cover all associated legal fees and costs. Our priority will be to
 rectify the situation promptly and ensure compliance moving forward.

### 3. Accessibility and Inclusion Coordination

## **Consultation with A&I Coordinator:**

 Coldwater Excursions will regularly consult with the Department's Accessibility and Inclusion (A&I) Coordinator whenever an ADA-related issue arises. This collaboration will ensure that we are adhering to best practices and making informed decisions regarding accessibility.
